Once IUP is contacted, dates are scheduled for each part of the consultation. (Safety and Health).

An opening conference takes place at the beginning of each visit to provide the employer of program objectives and obligations.

Consultation discusses and provides a summary of OSHA's frequently cited standards specific to the business NAICS.

## IUP CONSULTATION

A closing conference is held to discuss any identified hazards and the recommended corrective actions.

A written report is sent to the employer summarizing the findings and recommendations along with a “List of Hazards”.

The employer is to correct the “List of Hazards” and submit a final report showing how the hazards were corrected.




